- Max 80% Purchase
- Max 75% Refinance
- Minimum 660 FICO
- Loan amounts up to \$4M
- 3 Months Bank Statements required (unless >700 FICO & ≤70% LTV)
- CPA / registered tax preparer P&L on CPA's letterhead (most recent 12 months)
- All Occupancies
- SFR / Condo /Townhome (No rural or Non-Warrantable Condos)
- Reserves not required ≤ 75% LTV
